f you have been denied VA disability for your service-connected injury or illness, you may be eligible to file a Supplemental Claim.

In order to file a Supplemental Claim, you must add evidence that is *new* (or not provided to the VA previously) and *relevant* to your case. You can file a Supplemental Claim anytime, but it is recommended you file within one year from the date on your decision letter.

What's "new and relevant" evidence?

- *New* means that the VA didn't have this evidence before the last decision.
- *Relevant* means that it has to do with the issue(s) on appeal.

For example, filing evidence of a psychiatric diagnosis is not relevant to a back condition unless there is a diagnosis of pain syndrome that is causing the mental health condition. In other words, the evidence submitted must be linked to the condition on appeal, even if it is a secondary condition due to the original issue claimed.

Evidence can come in many forms:

- 1. Lay evidence: A statement from a nonprofessional attesting to your behaviors or physical conditions (a) for which you have not previously submitted a claim and (b) of which the VA has no previous knowledge. For example, on a PTSD claim, submitting a statement from a parent stating how your behaviors have changed from prior to service compared to after service.
- **2. Medical treatment records** from a medical provider, either private or the VA, that includes new information such as a new diagnosis, an increased level of severity, or a secondary diagnosis related to the issue on appeal.
- **3. Independent medical opinion** from an objective provider who has nothing to gain from or investment in either you or the VA. The provider is presented with documented evidence of the claim the same evidence the VA has reviewed and provides their unbiased opinion of the facts.

The PAC was chartered in 1938, making it West Virginia's oldest cultural agency in continuous operation.

The PAC Clay Studio is an inspirational place where everyone can explore pottery skills such as wheel throwing,

BUFFALO CHICKEN WRAPS

1-8 oz. pkg. cream cheese

2-12.5 oz. cans chunk chicken

1-8 oz. bottle ranch dressing

1-8 oz. bottle hot sauce (I prefer Red's)

1 package tortillas

1-8 oz. pkg. shredded cheese

(your choice)

DIRECTIONS: Combine the first four ingredients in a crockpot and cook on high for 3 hours; then reduce temperature to low and stir in half of the shredded cheese. Put a spoonful of the mixture on each tortilla, roll up and place in greased baking dish. Top with remaining shredded cheese and bake for 20 minutes at 350 degrees. Remove from the oven, let cool for a few minutes and enjoy.

4. Service records/Service medical records that the VA has not already reviewed which include new evidence of the issue; for example, medical records showing you received treatment for the condition in service where no prior records had been reviewed; or evidence of an event related to the condition. This can also include the service records of other military personnel who served with you. For example, if you are appealing a denial of PTSD and another service member in your unit received a Purple Heart for being injured by an IED while you were stationed together, that would be new and relevant evidence.

Filing a Supplemental Claim for **PACT Act-related conditions**

If the VA denied your claim in the past but now considers your condition presumptive, you should consider filing a Supplemental Claim. For example, this applies to Veterans who were exposed to burn pits, Agent Orange, or other toxic substances.
